



### Fair Housing Law Center

The Fair Housing Law Center is committed to our mission in offering education, legal representation, training and materials, and affirmatively furthering fair housing, to ensure access to housing free from discrimination. The Fair Housing Act (FHA) was passed in 1968 and has two main goals of preventing discrimination and reversing housing segregation.


Our office handles cases of prohibited acts against protected classes under the FHA. Prohibited acts range from making housing unavailable, steering, refusing to grant a reasonable accommodation or modification, sexual harassment, and more. Protected classes range from race and color, nation origin, religions, familial status and disability, and sex. Sex discrimination encompasses sexual orientation, gender identity, sexual harassment, and domestic violence.


The FHA has a broad range of those who are liable including owner, landlords, Housing Authorities, managers, maintenance workers, lenders, and realtors. The FHA is also broad in what is considered an eligible dwelling unit including apartments, mobile home parks, condominiums, single family homes, a room in which people sleep even if they share living spaces, public housing, nursing homes, dormitories, and group homes for people with disabilities. Some examples of Fair Housing matters our office handles are reasonable accommodation requests for emotional support animals for people with disabilities or reasonable modification letters to install a handicap accessible shower.

Our office also works with Clients to file a complaint with the United States Department of Housing and Urban Development or Pennsylvania Human Relation Commission when there has been a violation of the FHA. Housing Clients and cases are eligible for our services if they fall within one of our county coverage areas.

### SPHS CARE Center STTARS Program Human Trafficking Awareness/Stalking Awareness Month

January is Human Trafficking Awareness Month as well as Stalking Awareness Month. It is important to know how to recognize the signs of these and other abuses in order to stop them from happening in our communities and support those affected by these crimes.

Human Trafficking is a form of modern-day slavery where traffickers profit from the exploitation of others. It is a public health issue and crime that takes advantage of the most vulnerable among us and weakens the health and wellbeing of individuals, families, and communities.

Trafficking can take different forms. Sex trafficking includes commercial sexual exploitation of children, as well as instances where an adult is in the sex trade as the result of force, fraud, or coercion. Labor trafficking occurs when a person is forced or coerced to provide labor or services for the economic benefit of the trafficker.

Even though there has been increased awareness of this crime, human trafficking continues to go unreported due to its isolating nature, the misunderstanding of its definition, and the lack of awareness about its indicators.

According to the Stalking Prevention and Awareness Resource Center (SPARC), stalking is a pattern of behavior directed at a specific individual that would cause a reasonable person to fear for their safety or the safety of others; or suffer substantial emotional distress. Stalkers use a variety of tactics, including (but not limited to): unwanted contact including phone calls, texts, and contact via social media, unwanted gifts, showing up/approaching an individual or their family/friends, monitoring, surveillance, property damage, and threats. Anyone can be a victim of stalking. A majority of stalking victims are stalked by someone they know: a current or former intimate partner, acquaintance, or family member.

It is up to every business, community organization, faith community, family, and individual to make a difference by choosing products that are not made by forced labor; by working to protect our young people from sexual exploitation; by addressing the problem of internet sex trafficking and pornography; and by becoming more aware of the behaviors and attitudes that are conducive to sexual abuses. We must work together to find solutions.

The SPHS CARE Center STTARS Program staff has been trained to provide counseling and advocacy to survivors of sexual abuse, harassment, and assault, including sex trafficking and stalking in Washington and Greene Counties, and are proud to serve as a core team member of the Washington County Human Trafficking Taskforce. The taskforce is part of the Washington County STOP Team which focuses on sexual assault and domestic violence issues. Led by the Washington County District Attorney's Office, the taskforce brings together specialized law enforcement, victim services, and other providers with the focus of addressing and preventing trafficking in our area.

Increased community education on how to identify victims of human trafficking and sexual violence along with increased knowledge of local resources and services for those affected by these criminal actions, can help restore freedom and dignity to identified survivors, as well as diminish the number of future victims. The STTARS Program offers training for allied professionals and the community regarding a variety of sexual violence issues including Mandated Reporting, Trauma Response to Victims, and Sexual Harassment in the Workplace. STTARS can also provide flyers, brochures, and magnets for your workplaces and communities with local and national resources.
